  - b. AB #03- Referendum on Approval of GPSA Budget: Motion 1<sup>st</sup> R. Polansky & 2<sup>nd</sup> J. Richardson – various grammatical and procedural errors corrected to reflect that the ASASU Constitution and the GPSA Bylaws be worded the same. Bill passed.
  - c. AB #04 –Procedure for Amending Bylaws: Motion 1<sup>st</sup> R. Polansky & 2<sup>nd</sup> J. Richardson – to create language within the GPSA Bylaws that have the same meaning as the ASASU Constitution. For Example: Article 2: Procedure for Amending the Bylaws and Presenting Resolutions. Bill passed.
  - d. AB #05-Resolution on Presentation of Referenda: Motion 1<sup>st</sup> R. Polansky & 2<sup>nd</sup> M. Rutkowski – To correct the Referendum language. Suggested that the assembly refer to the website for the affected lines of the referendum (line 41, 42, 43, 44, 52, 53) Bill Passed.
