17 OMNIBUS REFERENDUM PRESENTATION

20 GRADUATE AND PROFESSIONAL STUDENT ASSOCIATION,

22 WHEREAS the Graduate and Professional Student Association of Arizona State
23 University must operate under a thoughtfully developed ASASU Constitution and GPSA
24 Bylaws which promote effectiveness, efficiency, and accountability, and
25

26 NOTING that three referenda to amend the ASASU Constitution have been proposed and
27 passed by the GPSA Assembly (Assembly Bills 35, 43, and 46 from the Eighth
28 Legislative Session) and stand ready for vote by all GPSA members during this 2010-
29 2011 spring semester, and

31 FURTHER NOTING that all three referenda were proposed and sponsored by the
32 Government Operations Committee which desires that the amendments be proposed to
33 students in as clear and concise a matter as possible, and

35 FURTHER NOTING that since the GPSA section (Title III) of the ASASU Constitution
36 is only six pages in total length,
37

38 BE IT ENACTED THAT upon passage of this bill all three referenda will be combined
39 into one omnibus proposal to revise Title III of the ASASU Constitution according to the
40 amendment referenda authorized by the GPSA Assembly through passage of the
41 Assembly Bills described herein. Copies of the proposed Title III (markup and non-
42 markup versions) are available in the Documents and Resources section of the GPSA

45 THE GPSA ASSEMBLY HEREBY DIRECTS the ASASU Elections Director to place the
46 following referendum item on a special election ballot during the spring semester no later than
47 May 6, 2011:

52 amend its section (Title III) of the Associated Students of Arizona State University (ASASU)
