 - b. Graduate College: Dr. Webber, reported students will receive an alert soon on online processes with graduate programs. Reported on Blackboard collapse over the summer, all resources have been pulled to get Blackboard running. Suggestion to share information on research grant with directors and administrators on programs, so they can distribute this information to their students. Announced National Rankings reports that will be released in October—data informing the report was collected in 2005-2006.

- a. AB #07. Sports & Entertainment Law Association, 1st M. Savage & 2nd A. Monroe. Sponsor: Ed Hermes. Conference on Sports and Entertainment Law will kick off the inaugural publication of a new law journal at ASU. Questions on itemized budget lines, clarity of expenses. M. Savage moved to table AB#07, A. Monroe seconds. Motion passes.
 - b. AB #08 AXE Capoeira at ASU; 1st M. Savage, J. Bradley 2nd. Sponsor: M. McCoy. Afro Brazilian Martial Arts Dance Festival will feature skills and talents of numerous Capoeira students and and masters, attendance and participation of graduate students who are also lead officers in the program. Free admission for graduate students. Funded amount: \$2000. Bill passes.
 - c. AB#07: E. Hermes moved that AB#07 be brought back from the table, motion was seconded by J. Firestone. Motion passes.
 - d. AB #07: E. Hermes moved to amend AB #07, seconded by S. Noguérón. Amendment reflects update in budget lines. Motion passes. The Assembly then voted on AB#07. Funded amount: \$2000. Bill passes.
 - e. AB #09: Law Students for Social Justice: 1st E. Hermes & M. McCoy 2nd. Sponsor: E. Hermes. Symposium “Balancing the scales of the criminal justice system” will address S.B. 1070 and H.B. 2525. This event will help launch online legal forum operated by the Law Students for Social Justice. Funded amount: \$1930. Bill passes.
 - f. AB #10. Pro Bono Board: E. Hermes 1st & A. Monroe 2nd. Sponsor: E. Hermes. Justice for All Night provides a forum to celebrate pro bono and public interest community, and raises funds for law students to provide services to individuals who otherwise could not afford legal services. Funded amount \$2000. Bill passes.

IX. Graduate Student Forum

- a. Conrad Ottey, Vice President of External Affairs presents report. Please see the published report on the GPSA website located at: <http://www.asu.edu/gpsa/assembly/> Currently in process of creating a graduate ad-hoc committee for the Arizona Students Association, encourages member to join. Next AZ Board of Regents Meeting is on the 23rd. Anticipating the rollout of a performance-based funding system plan. Drafted a Graduate Student Loan Debt Issues submitted by the Legislative Action Committee. Reported on plans to bring the gubernatorial candidates to Memorial Union for forum instead of debate.
- b. Proposition 107: Forum to open discussion on graduate students' stances about Proposition (Arizona Civil Rights Initiative). ASA has taken a stance in the issue. Bill will cut equal opportunity programs in higher education. Suggestions on moving this issue to External Affairs Committee. L. Peters brings up also the implications of Proposition 302 for graduate student community.
- c. Initiative for Ad-hoc Committee on International Students Issues: Y. Tsai brings up the possibility of starting a committee to support international students' concerns.
