18	WHEREAS the current GPSA Constitution and Bylaws do not reflect the current and preferred
19 20	responsibilities and positions within the GPSA Assembly leadership structure;
21	WHEREAS it is beneficial to the GPSA Assembly, and the graduate student body to have a
22	updated and accurate GPSA Constitution and Bylaws;

24	WHEREAS institutional memory and supporting future leadership in the GPSA is key to the
25	organization's success;

27	NOTING THAT this bill, if passed, will serve as a starting point for future leadership
28	conversations about the duties of the Directors;
29	
30	BE IT RESOLVED Title VI, Article 6, Section A be changed from;
31	GPSA shall hire the following directors: Executive Director of Communication
32	& Campus Relations, Director of Information Technology, Director of Graduate
33	Research, Director of Events and Professional Development Programming, Director of
34	Graduate Student Advocacy, Director of Legislative Affairs, and a Campus Director for
35	each of the West, Downtown Phoenix, and Polytechnic campuses. The Assembly
36	President pro tempore shall be considered a GPSA Director for the purposes of this
37	Article.

39	To: (Changed Language is Underlined)
40	
41	GPSA shall hire the following directors: Director of Communication, Director of
42	Information Technology, Director of Graduate Research, Director of Events, Director of
43	Graduate Student Advocacy, Director of Legislative Affairs, two Campus Directors. The

44	Assembly President pro tempore <u>and Assembly Secretary/Parliamentarian</u> shall <u>both</u> be
45	considered a GPSA Director for the purposes of this Article. The Executive Committee
46	shall have the power to appoint additional Directors as needed, with the approval of the
47	Assembly.

49	BE IT RESOLVED Title VI, Article 6, be amended to add a new Section B;
50	B. All Directors shall make available to the succeeding GPSA President and Assembly
51	President all documents and information relevant to the execution of the office by May
52	1, or by the termination date of the Director's position, whichever occurs first.
53	
54	BE IT RESOLVED Title VI, Article 6, Section B be re-numbered to reflect the previous change to
55	be Section C;
