# Accomplishments since previous meeting

## President

# Graduate Student Concerns: GPSA Presentation to Student-Faculty Policy Committee Arizona State University

## 1. Transparency of Programmatic Changes Impacting Graduation Timelines

- a. Students describe being uninformed of but expected to know about programmatic/departmental changes (e.g., curriculum/policy changes like changes to pre-requisites, class schedules, course availability, etc.) that could significantly impact their graduation timeline.
- b. Students uninformed of these changes face dropping out, greater financial strain, delayed graduation, etc.

## 2. Developing Student Handbooks for all Programs

- a. Students describe that handbooks are not equally developed for all programs, leaving some students without crucial information relevant to their success in their program.
- b. Students without formalized handbooks seem to be at the mercy of their advisors providing adequate information or turn to other students, who may not be articulating current policies and expectations set by program administration

# 3. Comprehensive TA/RA/GA/MA Contracts Outlining Duties and Expectations

- a. Students describe not having the duties, responsibilities, and expectations of their Assistantships formally specified.
- b. Without such documentation, students are unclear about their roles and responsibilities and of the parameters of their positions which could lead at best to disappointment on faculty members' end and at worst, exploitation on students' end.

## 4. Adequate Graduate Student Representation on Faculty Councils

- a. In line with ASU's model of shared governance, graduate students describe not being included in various representative bodies relevant to their colleges/schools
- b. Undergraduate students have seats on their Faculty Councils while GPSA does not have this same representative opportunity at the graduate level

## 5. Developing a Graduate Student Bill of Rights

a. Students describe wanting an easily understandable, cohesive, centralized document enumerating the rights of graduate students pertaining to their unique roles as students, teachers, researchers, and employees
